

- To build and strengthen society for health care, education and socio-economic development through community initiatives and participation.

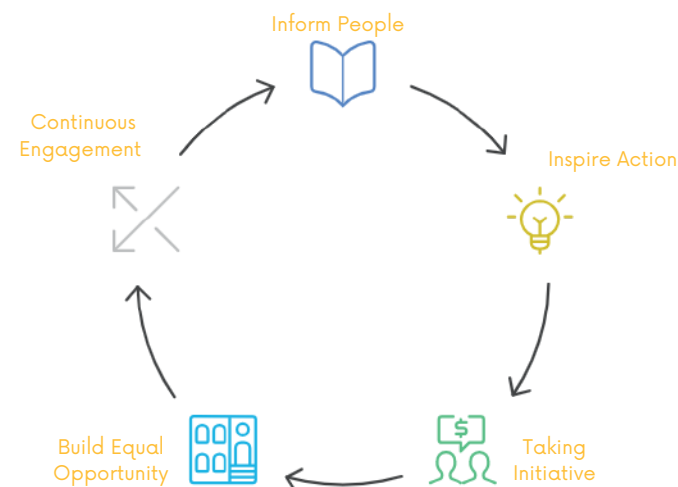

MALSAWM ABILITY RESOURCE CENTRE



MALSAWM ABILITY RESOURCE CENTRE (MARC), an all-in-one platform, empowers persons with disabilities by enhancing their skills for independent life, ensuring inclusion in regular schools, sensitizing schools and providing quality education, training teachers on disability issues and effective teaching techniques, strengthening parents' knowledge and confidence and collaborating with community organizations and NGOs to promote disability rights.

Components of MARC



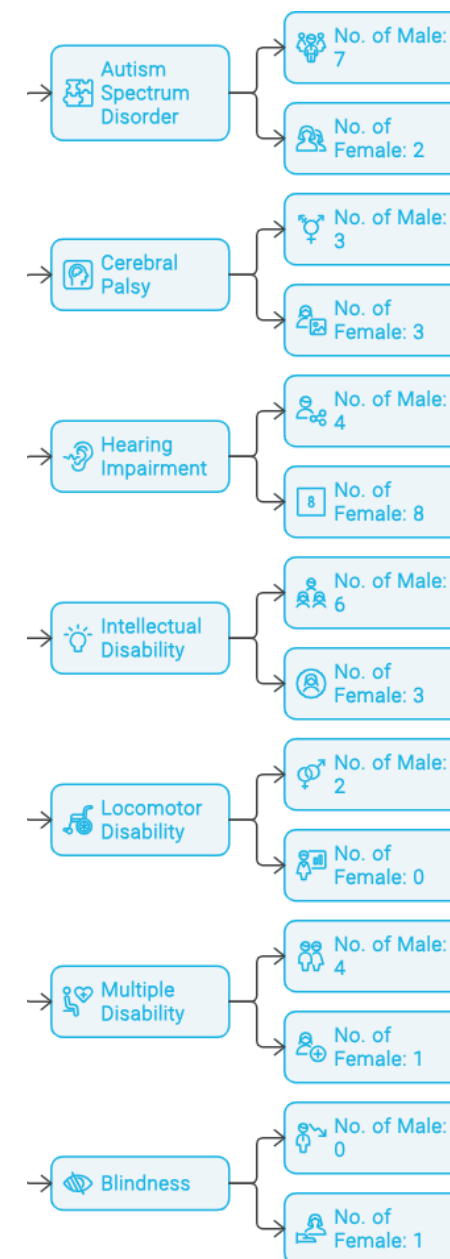
The Malsawm Initiative (TMI)

The Malsawm Initiative (A School for Children with Disabilities) provides appropriate education based on specifically designed Individualized Education Plan (IEP) to 44 children with various types of disabilities ages ranging from 4-17 years. They are grouped in three sections of Early Education; Level A (Class I-III), Level B (Class IV-V), Level C (VI-VII); and Pre-Vocational Group based on their ability and age appropriateness. Level A, B & C comes under Open Basic Education program of NIOS, of which TMI is an accredited agency since 2019. Through this program, 3 students appeared for Level A, 6 students for Level B and 4 students for Level C examination in 2024. Students are also taught braille and sign language based on their need.



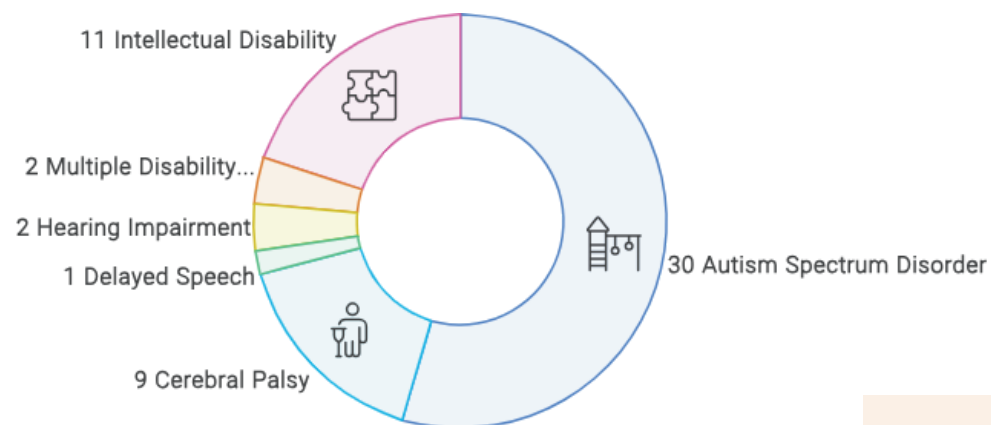
IMPACT STORY

Pauginsean, an 8-year-old boy with ADHD, found hope and excitement at TMI. Previously marked by tears and resistance, his school days transformed. The nurturing environment helped him blossom socially and academically, making friends, leading conversations, and improving his writing skills. He even developed a fondness for vegetables. Hesitant and anxious parents once, marveled at his vibrant transformation, a testament to the profound impact of understanding and acceptance in a child's potential.



Early Intervention Unit (EIU)

EIU provides behavior management, activities of daily living (ADL) skills, school readiness and counseling to 55 children with various types of disabilities ages ranging from 0-17 years. Of the 55 beneficiaries, 20 beneficiaries with Autism, Cerebral Palsy, Intellectual Disability and Multiple Disabilities are covered under Disha scheme (Early Intervention and School Readiness) of the National Trust. 12 beneficiaries graduated and successfully transitioned from EIU to TMI.

IMPACT STORY

Jamgunhao is a 4-year-old boy with ASD, shown significant improvement in various areas since joining EIU since 2023. He had difficulty following instructions, social interaction, verbal communication, and attention, as well as resistance to using the toilet. Through interventions focused on language and communication, socialization, and life skills such as eating, brushing, and toileting, he has made great strides. He starts expressing his wants, needs, likes, and dislikes verbally using a few words, and has shown the ability to play with his friends. As a result of his progress, he is promoted to The Malsawm Initiative.



Inclusive Education Programme

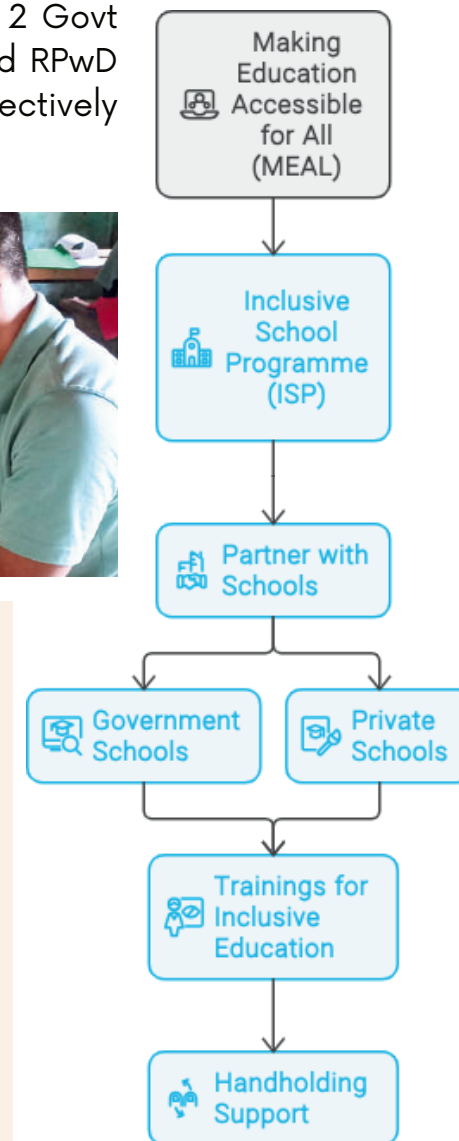
CCI promotes inclusive education and work through its project “Making Education Accessible for All (MEAL)” with support from Wipro Foundation for ensuring every child including children with disabilities can access quality education and participate fully in the school community. CCI partners with 2 Govt Schools and 4 private school for developing them into an inclusive school according to RTE and RPwD Act. CCI Resource Teachers capacitated these schools and provide continuous support to effectively include children with diverse needs and backgrounds.



RIPPLE EFFECT : Inclusive Education in Action

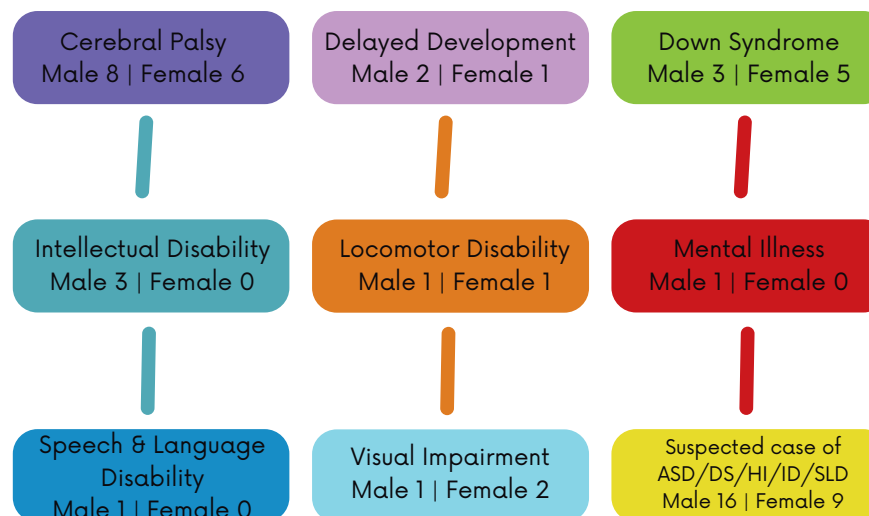
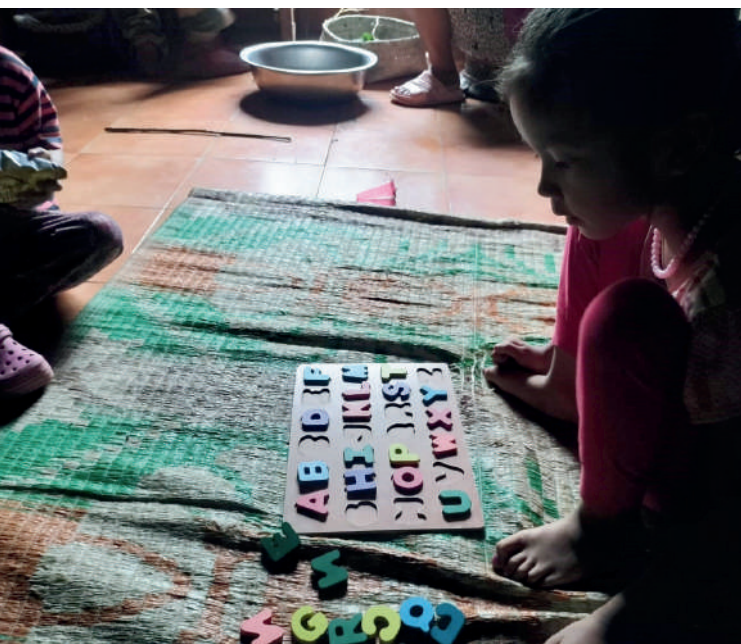
Effective capacity building for inclusive teaching and preparation for Teaching & learning materials could be made with staff from 6 partner schools. Various Inclusive Teaching and Learning Materials have been developed and proven to be effective with partner schools. As example, **“Parts of a plant”**

which has had a positive impact on both teachers and students. The materials are locally available and designed to be visual, tactile and kinesthetic providing a hands-on learning experience for students. The 3D model of the petals allows students to not only see and feel the shape and size, but also touch the leaves, roots and soil. Real leaves, stems and soil are used in these learning materials enhancing the sensory experience for the students.



Home Based Care Unit (HBCU)

HOME BASED CARE UNIT (HBCU) caters the age group of 0-17 years who are confined at home due to the severity of their disability and/or other extraordinary challenges in their family. A total a 60 beneficiaries were covered under this program through Home School Program under MEAL . Of the registered 60 beneficiaries, 5 children joined mainstream school, 4 joined TMI and 1 is in our EIU.

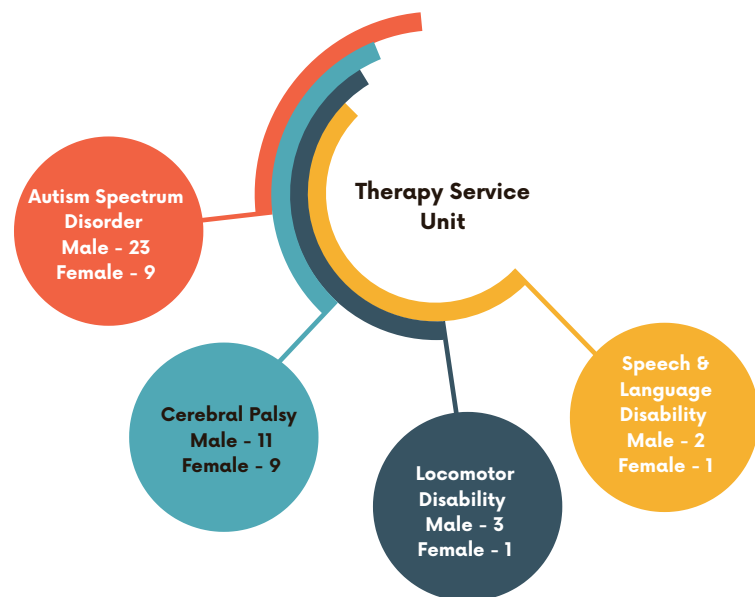


IMPACT STORY

Ms Vunghthianhoih with Cerebral Palsy, struggling to stand and walk independently joined our MARC. Her disability confined her at home and never had the opportunity for education of any kind. After registering, her parents and teachers joined hands for the all-round development of the child. She can now brush her teeth independently, and can also spread and fold a mat that has been used for therapy session. Academically, she can now identify alphabets, primary colours, numbers and shapes using pegboards.

Therapy Services Unit (TSU)

THERAPY SERVICES UNIT (TSU) caters to the therapy needs of students and beneficiaries under TMI, EIU and HBCU of MARC. Therapy includes physiotherapy, sensory integration and speech & language enhancement which were availed by a total of 59 beneficiaries. 20 of the beneficiaries were from HBCU covered under Home School Program of MEAL. As its the only well equipped Therapy services in the town and it is opened to those who could avails our services and lot of services are provided to the community .



IMPACT STORY

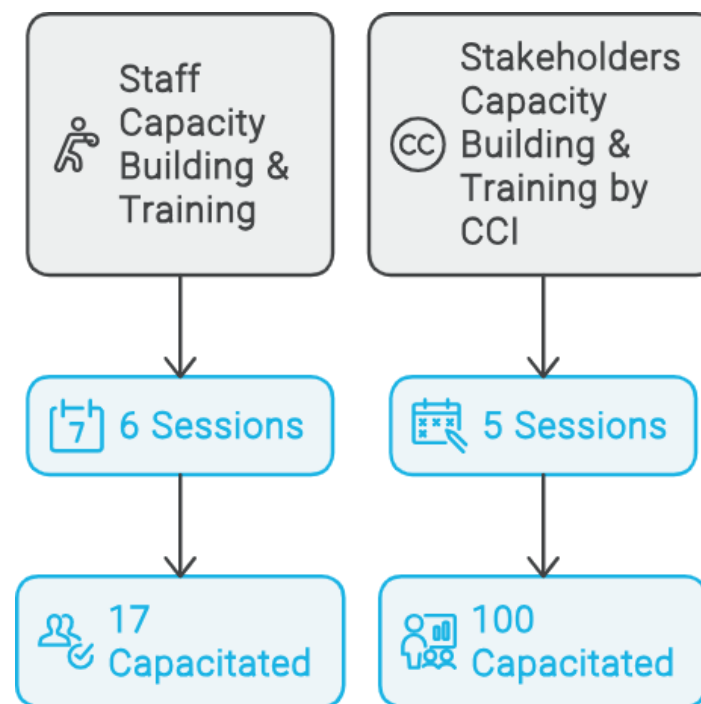
Nemlunmawi @Mawi, a 5-year-old with Cerebral Palsy, has surpassed expectations through her journey after enrolling in 2022. Initially standing with support, she quickly advanced to standing unaided for several seconds, and then completely on her own. Mawi now walks independently, even overcoming the challenge of a tactile school corridor, and identifies both upper- and lower-case alphabets, reads simple words. Her ability to pick herself up after falls showcases her resilience and determination, embodying the transformative power of early intervention and unwavering support.



Capacity Building & Training (CB & T)

CAPACITY BUILDING & TRAINING is an essential part of CCI's programmes for its staff members as well as stakeholders like parents, siblings, teachers, etc. Regular in-house sessions are conducted for staff members to enhance their knowledge and skills so that they are equipped with necessary tools to effectively address the diverse challenges they encounter while working with children with disabilities and diverse needs. Awareness and skill-building sessions are also conducted to educate parents, siblings and other stakeholders to empower them so that they can support children with disabilities and diverse needs better within their respective roles and environments.

With shortage of professional staff in the region, CCI sponsored one of its staff for 5 yrs course in Bachelor of Occupational Therapy at NILD, Kolkata



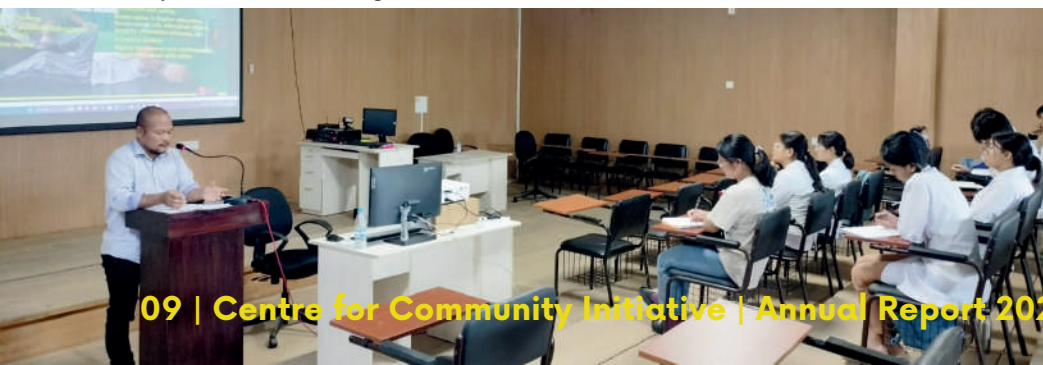
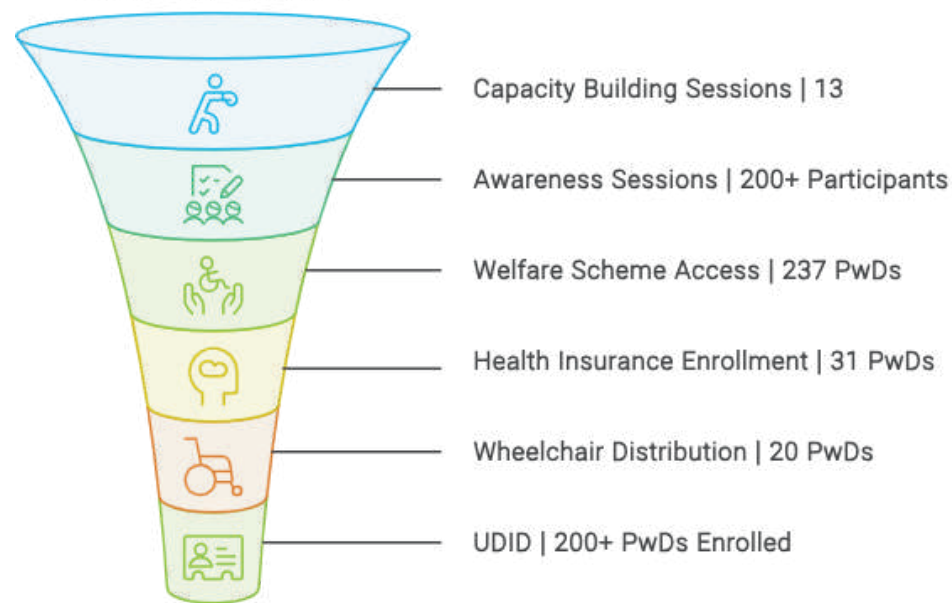
ADVOCACY & COMMUNITY EMPOWERMENT

Centre for Community Initiative (CCI) actively supports persons with disabilities (PwDs) and marginalized communities through various programs. CCI organized a capacity-building session on the RPD Act 2016 at Churachandpur Medical College and awareness sessions at 4 Inclusive Community Learning Centers (iCLC), discussing rights-based approaches and types of disabilities. In collaboration with District Social Welfare Office, CCI also raised awareness about RPWD Act and inclusive elections during the SVEEP campaign.

CCI helped 237 individuals access welfare schemes, conducted sessions on the NIRAMAYA Health Insurance Scheme, and enrolled 200 PwDs for UDID cards.

In response to the crisis in Manipur, distributed 20 wheelchairs to IPDs in relief camps in Lamka, aiding over 8,000 displaced individuals.

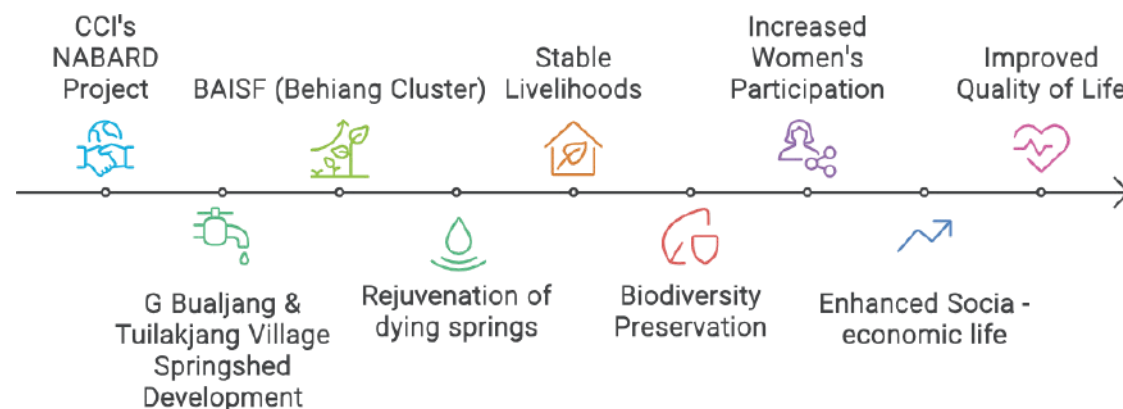
CCI's Coordinator (Advocacy) filed a Public Interest Litigation (PIL) in the High Court of Manipur under the Rights of Persons with Disabilities Act, 2016, for accessibility of Mini Secretariat in Churachandpur. State authorities are now working to improve accessibility in public buildings.



LIVELIHOOD & SUSTAINABLE DEVELOPMENT

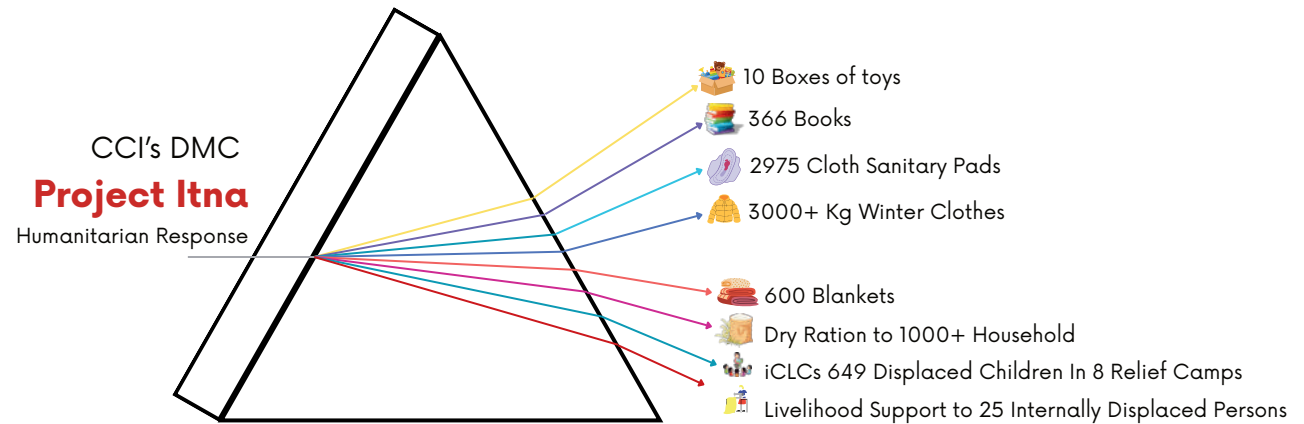
Centre for Community Initiative in collaboration with **NABARD**, is driving two key projects for community welfare and development in remote areas of Churachandpur district. The first project, **Springshed Based Watershed Management Project**, is being implemented in G Bualjang and Tuilakjang villages in Suangdoh Sub Division. This project focuses on conserving and restoring natural springs and their surrounding catchment areas to ensure sustainable water supply for communities. It emphasizes holistic watershed management practices, including reforestation, soil conservation, and sustainable agriculture, to enhance water quality, biodiversity, and resilience to climate change.

The second project, **Border Area Integrated Sustainable Farming (Behiang Cluster)**, under Tribal Development Fund (TDF) is being carried out in 7 villages under Singngat Sub Division, benefiting 200 farmers. The main crops include Grafted Avocado and Mango (Malda). This project aims to improve the socio-economic lives of tribal families through sustainable farming, promoting stable livelihoods, reducing distress and migration, enhancing quality of life, and increasing women's capacity and participation in the development process.



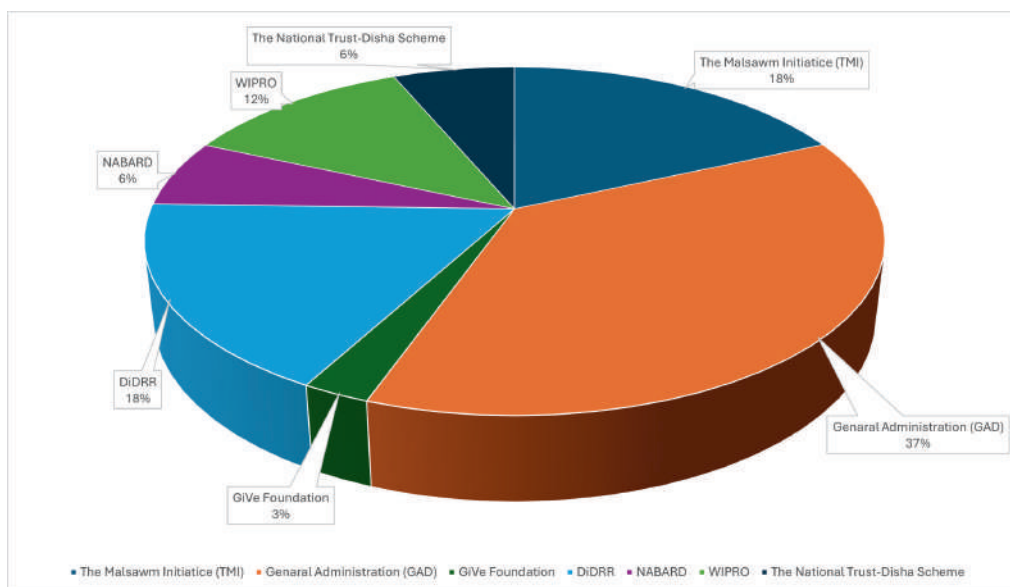
DISABILITY INCLUSIVE DISASTER MANAGEMENT (DiDM)

CCI DiDM's Disaster Management Committee (DMC) responded humanitarian crisis in Manipur in the name of **Project Itna (love)** by focusing education, healthcare, hygiene, daily essential needs and livelihoods for Internally Displaced Persons (IDPs). Educational and nutrition food for children under Inclusive Community Learning Centre (iCLC), sanitary pads, sessions on hygiene, and winter clothing & blankets provided at relief camps. Dry rations distributed, organised medical camps for IDPs while providing emotional support. Provide economic sustenance to IDPs including to visually impaired.

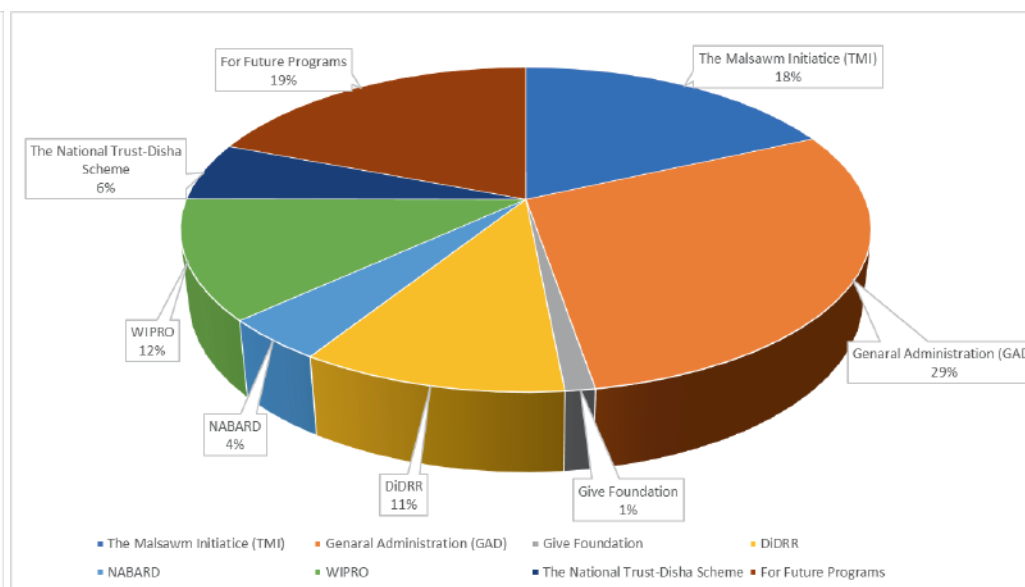


FINANCIAL REPORT
